| <b>Protect Official and Confidential Information</b> | <p>The board is not an appropriate forum for the discussion of individual school staff, students, parents or other members of the school community.</p> <p>Board members respect the need for confidentiality and privacy with regard to sensitive matters that might arise at board meetings, especially where there are matters of a personal nature relating to staff, students or parents.</p> <p>All board members treat discussions relating to individuals with discretion, protecting the confidentiality and privacy of the people involved.</p> <p>If a board member is approached regarding an operational matter, the parent should be encouraged to speak with the principal or classroom teacher.</p> <p>Matters concerning policy or procedure may be placed on the meeting agenda by the Chair and approached in a generic sense to protect the privacy of individuals involved.</p> |
| <b>Behave Honestly</b>                               | <p>Members of the board do not engage in dishonest, misleading, fraudulent, or corrupt behaviour.</p>                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                |
| <b>Declare and Manage Conflicts of Interest</b>      | <p>Board members ensure personal or private interests, and those of family or associates, do not conflict with, or influence, their decision making.</p> <p>Board members declare any conflicts of interest when they arise.</p> <p>Board members who have declared a conflict of interest are not entitled to vote on that issue.</p> <p>There is no requirement for board members who are also current members of Parliament or local government or are planning to nominate as candidates for an election, to resign from the board. However, it may be appropriate for these members not to attend board meetings in the period leading up to the election if the board or the member considers there is a real or perceived conflict of interest.</p>                                                                                                                                           |
